

By Submitting This Application You Understand The Following:

- Your application can take up to 48 hours to be processed
 - Each applicant is to complete an application form
- Each applicant is required to submit 100 points of identification, which **MUST** include **Photo ID and proof of income i.e. payslips/centerlink statement**
- Each applicant is required to provide two personal references (not family) and a Next of Kin (parent, sibling or guardian)
- If approved the first two weeks rent must be paid in cash to our office within 24 hours of approval
- If approved all applicants must make an appointment to come into our office (together) and sign all documents within 24 hours of approval
- A full bond equal to four weeks rent plus the first two weeks rent (a total of six weeks rent) must be paid prior to us handing over the keys for property
- After the initial payment of bond and two weeks rent, we do not accept rent payments in cash
